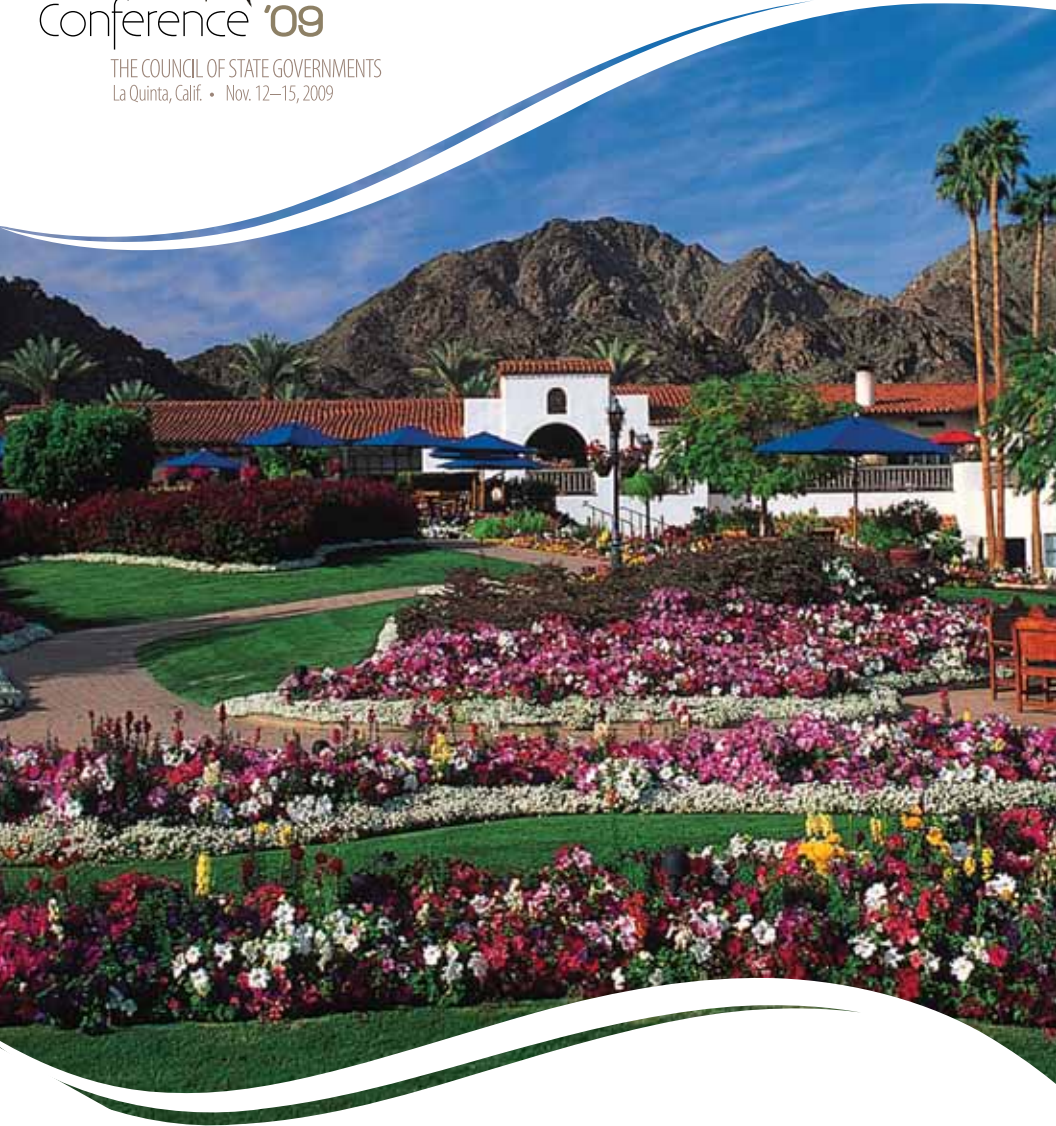


We hope you find your time in La Quinta to be informative and energizing and that the beautiful desert setting gives you time to reflect on how best to make a difference.



Common Humanity: Finding Our Place in the World

SPENCER WELLS, PH.D. | Friday, Nov. 13, 7:30–9 a.m.

Spencer Wells is a leading population geneticist who, as *National Geographic* Explorer-in-Residence, leads the Genographic Project. The scientist, author and documentary filmmaker has dedicated much of his career to studying humankind's family tree and closing the gaps in knowledge about human migration.

Wells calls the Genographic Project "a dream come true." The project builds on his earlier work, featured in his book and television program, *The Journey of Man*. Wells is working in collaboration with other scientists around the world to capture an invaluable genetic snapshot of humanity before modern-day influences erase it forever.

Wells earned his doctorate at Harvard University and conducted post-doctoral training at Stanford University's School of Medicine. He is committed to studying genetic diversity in indigenous populations and unraveling age-old mysteries about early human migration.

Ben Self is a founding partner of Blue State Digital, a leader in online fundraising, advocacy social networking and constituency development programs for nonprofit organizations, political candidates and causes, and corporations.

During the 2008 election cycle, Self served as the Democratic National Committee technology director and supervised the technology projects of the national party, focusing specifically on the Web site, computer infrastructure, compliance software and national voter file database. In this role, he led projects that entirely revamped the technology of the national party, including a complete replacement of the Web site and the Democratic Party's national voter file, VoteBuilder.

Throughout his career, Self has gained extensive experience in new media technologies, statistical data analysis, data warehousing, database architecture and administration, system design and system development.



America: An Evolving Nation

JON MEACHAM | Saturday, Nov. 14, 12–1:30 p.m.

Jon Meacham, Pulitzer Prize winner, editor of *Newsweek* and author of *Franklin and Winston* and *American Lion*, was named "one of the most influential editors in the news magazine business" by *The New York Times*. Meacham won a Pulitzer Prize this year for *American Lion*, a biography of Andrew Jackson. A skilled raconteur and eloquent speaker, Meacham understands important issues and events in all their complexity and the impact they have on our lives.

At *Newsweek*, Meacham supervised the magazine's coverage of politics, international affairs and breaking news, and has written cover stories on politics, religion, guns in America, race and the death of Ronald Reagan. In 2001, he was key in editing the magazine's coverage of the Sept. 11 terrorist attacks, and oversaw both domestic and international reporting.

Meacham has also written for *The New York Times Book Review*, *The Washington Post*, the *Los Angeles Times Book Review* and *The Washington Post Book World*. Before joining *Newsweek*, Meacham was an editor for two years at *The Washington Monthly*.

Shirley S. Abrahamson

Shirley S. Abrahamson has served as chief justice of the Wisconsin Supreme Court since 1996. She was the first woman to serve on the court when she was first appointed in 1976.

Abrahamson, who graduated from the Indiana University Law School, also served as a professor at the University of Wisconsin Law School. She is a past president of the National Conference of Chief Justices and past chair of the board of directors of the National Center for State Courts. She also served as chair of the National Institute of Justice's National Commission on the Future of DNA Evidence.

Sue Bell Cobb

Sue Bell Cobb took office as chief justice of the Supreme Court of Alabama in 2007 after serving 12 years on the Alabama Court of Criminal Appeals.

Cobb graduated from the University of Alabama School of Law in 1981. As soon as she was admitted to the bar, she was appointed district judge of Conecuh County becoming one of the state's youngest judges. She was elected twice to that position. She was appointed to serve as an alternate chief judge on the Court of the Judiciary in 1997, and was elected to the Court of Appeals in 1994.

Paul J. De Muniz

Paul J. De Muniz joined the Oregon Supreme Court in January 2001 and became Oregon's 41st chief justice on Jan. 1, 2006. In 2008, he was elected to the board of directors of the Conference of Chief Justices and is one of eight state chief justices selected to attend a three-year Harvard University Executive Session to study the role of state court leaders.

De Muniz, who graduated from the Willamette University College of Law, has also served on the Judicial Fitness and Disability Commission and the Supreme Court Access to Justice for All Committee. In 2002, he founded a now-flourishing rule-of-law partnership with judicial leaders in Russia's Far East.

John D. Minton Jr.

John D. Minton Jr. was sworn in as Kentucky's fifth chief justice June 27, 2008, after serving two years as a justice on the state Supreme Court.

Minton, who graduated from the University of Kentucky College of Law in 1977, was appointed to the court in July 2006 and was then elected to an eight-year term in November 2006 to represent the Second Supreme Court District, which is comprised of 14 counties in western Kentucky. He had previously served on the Kentucky Court of Appeals, and before that served as a circuit court judge in Warren County, Ky., where he served as chief regional judge of the Green River Region.

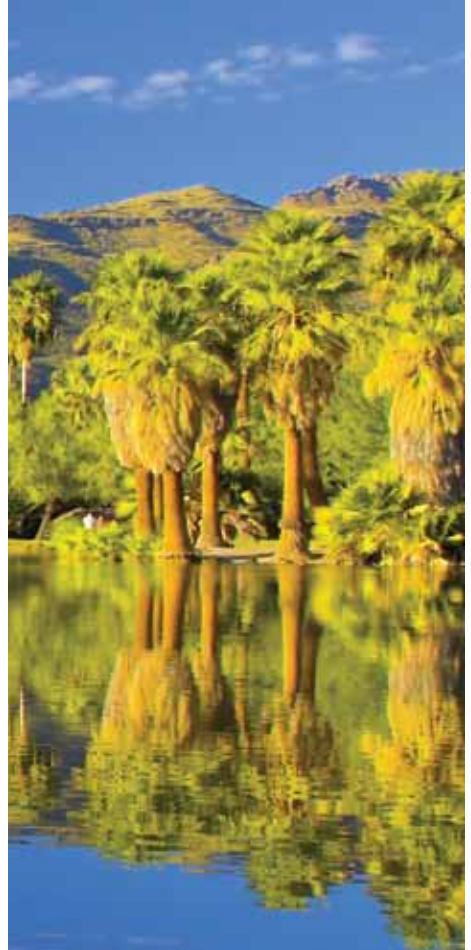

Transforming Government: The Tools You Need

Frank Capra A & B

Today's world is turbulent, dynamic and interconnected. The challenge for states is to become more responsive to the rapidly changing environment in which they operate. That task is becoming increasingly difficult in the midst of revenue shortfalls, job losses and business closings. State officials need strong tools to assist their states in transforming government into a more agile, focused and responsive instrument for meeting the needs of citizens. This half-day policy seminar, focused on the specific tools for transforming state government, will include panels on results-based governance, and transparent governance with each panel tied to real transformative tools and processes for change that can apply to the states.

America's Educational System Goes Back to School

Frank Capra A & B

By 2020, the U.S. could face a shortfall of 14 million workers who have the knowledge and skills needed to compete for middle-income jobs in a global economy. About half the students who enter college are not prepared for college-level courses. Forty percent of students at four-year institutions and 63 percent at two-year colleges must take remedial education. According to Measuring Up 2004, the timely completion of certificates remains one of the weakest aspects of performance in higher education. States traditionally have tasked high schools with preparing some students for college and the rest for the work force. As the need for college education grows, some high schools are striving to create an educational environment that prepares all students with the knowledge and skills to succeed in higher education. This session will focus on changes the U.S. educational system must make to compete globally.

Paving the Future: State Transportation Spending

Fiesta 3 & 4

2009 was supposed to be the year of transportation. The stimulus bill injected much needed capital into transportation infrastructure projects identified by states as "shovel-ready." That was supposed to be followed by new long-term legislation to authorize federal transportation programs, which would provide another historic cash infusion to shore up the nation's crumbling infrastructure. But the authorization bill put forward by the U.S. House Transportation and Infrastructure Committee struggled to gain traction as Senate leaders and the Obama administration instead sought a short-term extension of the existing transportation legislation to allow time to consider how to raise revenue needed for a major overhaul. This session will include an update on where things stand in the federal authorization process and how state policymakers may be impacted. The session will also include, as part of the launch of a CSG preliminary report on shovel-ready projects, a conversation with a cross section of the individuals put in charge of overseeing implementation of the American Recovery and Reinvestment Act in their states.

Tracking the Federal Stimulus Dollars

Flores 1 & 2

As states grapple with the worst economic downturn since the Great Depression, the role of the 2009 American Recovery and Reinvestment Act in rejuvenating and rebuilding the U.S. economy remains of great interest. While the huge influx of federal stimulus money to state and local governments offset a sharp drop in tax collections, state policymakers face a great deal of responsibility to ensure these federal funds are spent effectively and efficiently, and will build the foundation for broad-based, sustainable economic growth. This session will feature California's efforts to ensure the proper expenditure of federal stimulus funds as well as some of the broad trends gleaned from the projects initiated under the Recovery Act to date.

Will Health Care Get a Face Lift?

Fiesta 1 & 2

Congress is deep in debate over how to overhaul American health care. While most agree with general goals to extend health insurance coverage to the uninsured, to bend the curve on escalating health care costs and to improve the nation's health outcome measures, few agree on where and how to nip and tuck the current system. The decisions will obviously have tremendous impacts on states. This session will address the needed state policy changes—for Medicaid, insurance regulation and state employee insurance coverage—as well as timelines for change. The discussion will also address how much of the increased bill states will be forced to pay.

Looking Overseas to Drive America's Recovery: What Role Can Trade Play?

States spend an estimated \$100 million collectively on trade promotion; the federal government spends a little more than twice that amount. But the U.S. is still being outspent on a per capita basis by its major trading partners such as Canada and most European countries by as much as 20-to-1. Major economic players such as Germany are restructuring policy priorities to address serious export slumps. This session will address what the U.S. can do to help small companies survive and thrive.

Energy Intervention: Alternatives to Oil

Fiesta 3 & 4

Rising oil prices and potential security risks posed by an over-reliance on foreign sources of oil heightens the need for the U.S. to explore alternatives to oil, especially in light of regulations governing CO₂ emissions. Panelists at this workshop will discuss the potential for emerging technologies—including coal-to-liquids, biofuels and plug-in hybrid electric vehicles—to quench our thirst for oil.

Corrections in the Crosshairs: What Are States Doing to Increase Public Safety While Cutting Prison Spending?

Fiesta 6

State spending on corrections has risen faster in the past 20 years than spending on nearly any other state budget item—increasing from \$10 billion to \$45 billion a year. Unless policymakers act, state spending on corrections will grow by at least \$20 billion over the next five years. Federal judges in California, where prison crowding has reached record levels, have ordered the release of 43,000 state prisoners. While crime has dropped in the Golden State, its prison population has soared. But New York state is closing prisons as its crime

rates plummet: The number of homicides in New York City recorded in 2009 projects to be the lowest since the city's police department started keeping records in 1962. Why are corrections and crime trends so different in states? What can elected officials do to spend less on corrections while increasing public safety?

States' Financial Life after the Stimulus

Flores 1 & 2

State financial systems face tremendous challenges from the structural shifts transforming our national economy. The transition of our economy to one dominated by the service sector, the surge in online transactions and the extreme volatility of traditional revenue categories all pose difficult policy choices. In addition, massive upheavals in the credit markets in the last year pose challenges to state and local governments at a time when accumulating higher levels of debt loomed as a viable strategy. This session will feature renowned national experts discussing how states are faring in the credit markets and the forecast in the near and medium terms.

States' Rx for Health Reform

Fiesta 1 & 2

States have not waited for the federal government to act on health reform; they are leading the way. Massachusetts boldly mandated health insurance coverage, created an insurance connector and provided subsidies for low-income individuals. Now 97 percent of Bay State residents are insured. Maine and Vermont are also standouts in the move to provide coverage for all state residents. Several other states have pursued strategies to cover all children. Other states, including Iowa and Minnesota, are moving forward with cost containment and quality improvement strategies. This session will include a review of model state strategies, lessons learned and application of state policy to the national health care debate.

Health Care Cost Drivers: Alzheimer's and Diabetes
Fiesta 1 & 2
Nearly half of all Americans suffer from chronic diseases, such as diabetes, hypertension and pulmonary disease, driving 75 percent of annual health spending in the U.S., and an even higher proportion in Medicare and Medicaid. Many of these illnesses could be prevented through lifestyle interventions, such as diet, exercise and not smoking. In addition, for those already affected by the diseases, care management practices can increase compliance with treatment regimes and is shown to reduce devastating and expensive complications. Alzheimer's, a chronic disease with growing cost implications, only complicates disease management for other co-occurring chronic diseases.
Keeping the Promise: OPEBs and State Pension Liability
Frank Capra A & B
At a time when states face unprecedented fiscal challenges, a number of critical issues such as state pensions have been pushed aside as policymakers grapple with the immediate challenge of acute budget shortfalls. Notwithstanding the complex fiscal environment, the state pension issue remains one of the most nettlesome issues to navigate and requires the urgent attention of state policymakers. This session will feature updates from two states that continue to wrestle with this complex challenge, including details on remedial measures initiated to address pension liabilities and "other post-employment benefits"—commonly called OPEB—liabilities.
Broadband: If You Build it, Will They Come?
Fiesta 3 & 4
Broadband is described as the great enabler—a tool to open doors of opportunity for all Americans no matter where they are. Long on plans but short on funds, the broadband movement recently saw a massive injection of funding from the 2009 federal stimulus bill. While more than two-thirds of American households subscribe to broadband Internet, less than one-third of the

population has access—signaling an increased digital divide, especially in the South. Examining the status of broadband in the U.S., this session will explore how states are promoting access and using the federal stimulus dollars to connect citizens.

Who's in Charge? Succession Planning Before the Crisis

By their very nature, crises and emergencies occur without warning. As such, without proper planning and organization, governments and agencies can often spend precious time deciding who's in charge and how to proceed rather than actually responding and solving problems. Such planning involves proper succession plans for state leaders and in-depth continuity of government planning for the programs and services necessary to sustain governance. Under discussion will be the 2009 legislative crisis in New York and the impacts it has on succession; operational perspectives and insights into continuity of government standards and planning; and multi-branch perspectives on succession and continuity of government planning/issues.

CSG SPOTLIGHT: The Southern Collaborative on Obesity Reduction Efforts, or SCORE, project is a state-based approach comprised of teams of executive and legislative policymakers focused on facilitating the implementation of state wellness plans in their states. Similarly, 55 percent of the population will need college degrees by 2025 to equal the degree attainment rates of top-performing countries. With funding from the 21st Century Foundation, CSG created the National Advisory Council on Postsecondary Education Access to address the benefits of providing a seamless transition from high school to postsecondary education through a variety of rigorous curricular programs and to advance policies necessary for implementation. Learn from council members how your state can adopt and implement state policies for Advanced Placement courses and exams, International Baccalaureate Programs, Dual Credit, Dual Enrollment, Early/Middle High School Programs, P–16/P–20 governance and funding issues related to high school reform that will result in an increased number of high school students enrolling in postsecondary education.

Good Neighbors: States, Military Bases Partner on Environment*Frank Capra D & E*

The Department of Defense's ability to train today's armed forces is often compromised by activity around military bases. Wind farms can disrupt flight training; lighting from houses and street lamps can compromise night-time infantry training; and potential noise disturbances can force the military to restrict artillery practice to specific times of day. Mutual understanding between installation commanders and state and local officials can result in legislation and best practices that ensure sufficient buffer zones between residences and installations, reroute civilian obstacles to less intrusive areas, and limit restrictions governing training. This session will focus on how that understanding can provide the military the space and freedom it needs to fully prepare for its operations and at the same time allow the host community to benefit through the development of conservations and recreation spaces.

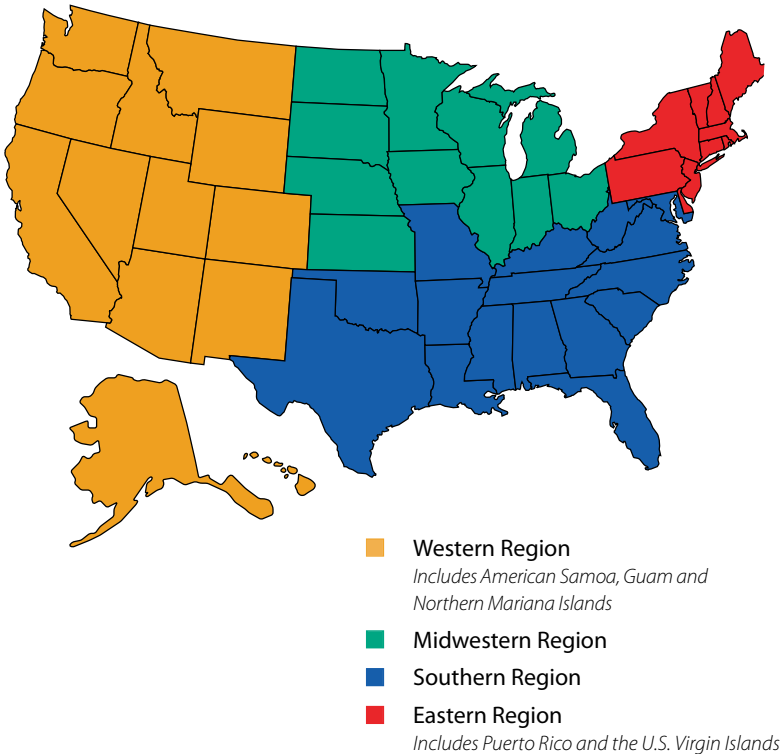
