

Wireless Privacy

This Act prohibits wireless telephone companies from publishing the names and telephone numbers of the companies' wireless telephone customers in a publicly accessible wireless telephone database without the express consent of the customers. It prohibits those companies from charging subscribers a fee for not listing the subscribers' numbers in such a database.

Suggested State Legislation

1 Section 1. [*Short Title.*] This Act may be cited as “An Act to Protect the Privacy of
2 Wireless Telephone Subscribers.”

 Section 2. [*Definitions.*] As used in this Act:

5

 (A) “Service supplier” means a person or entity who provides wireless service to a
6 telephone subscriber.

7

 (B) “Traditional telephone directory” means a telephone directory, in any format,
8 containing a majority of the landline telephone numbers for the given geographic coverage area
9 for that directory.

10

 (C) “Wireless service” means “commercial mobile service” as defined under Section
11 332(D) of the Federal Telecommunications Act of 1996 (47 U.S.C. Section 157, et seq.),
12 regulations of the Federal Communications Commission, and the Omnibus Budget
13 Reconciliation Act of 1993 (P.L. 103-66) and includes real-time, two-way interconnected voice
14 service which is provided over networks which utilize intelligent switching capability and offer
15 seamless handoff to customers. The term does not include one-way signaling service, data
16 transmission service, non-local radio access line service, or a private telecommunications
17 service.

 (D) “Wireless telephone database” means any collection of telephone numbers that
19 identifies the names and telephone numbers of multiple subscribers of one or more service
20 suppliers.

 Section 3. [*Criteria for Including Names and Numbers of Subscribers in Any Wireless
23 Telephone Database.*]

24

 (A) A service supplier or any direct or indirect affiliate or agent of a service supplier
25 providing the name and dialing number of a subscriber for inclusion in any wireless telephone
26 database which is or will be made publicly available shall not include the dialing number of any
27 wireless service subscriber without first obtaining the express consent of that subscriber.

28

 (B) The subscriber's consent shall meet all of the following requirements:

29

 (1) It shall be recorded in oral, electronic, or written form;

 (2) It shall be:

31

 (a) A separate document that is not attached to any other document or if it
32 is within another document shall be in a separate section of the document that includes the
33 disclosure;

34 (b) A separate screen or if it is within another screen shall be in a separate section of the screen
35 that includes the disclosure; or

36 (c) A sound recording of a discrete verbal confirmation;

37 (3) It shall be unambiguous and conspicuously disclose that the subscriber is
38 consenting to have the subscriber's dialing number sold or licensed as part of a publicly
39 accessible wireless telephone database; and

40 (4) The service supplier must disclose in an unambiguous and conspicuous
41 manner to the wireless customer that upon consent:

42 (a) the customer is agreeing to have his or her wireless number accessed
43 by anyone who utilizes the wireless telephone database; and

44 (b) if the customer has a rate plan that charges the customer for usage, that
45 calls received as a result, unsolicited or otherwise, will be applied against the subscriber's
46 planned minutes.

47 (C) A subscriber who provides express consent pursuant to subsection (B) of this section
48 may revoke that consent at any time. A service supplier shall comply with the subscriber's
49 request to opt out within a reasonable period of time, not to exceed [60 days].

50 (D) A subscriber shall not be charged for making the choice to not be listed in a publicly
51 accessible wireless telephone database.

52 (E) This section does not apply to the provision of telephone numbers to the following
53 parties for the purposes indicated; provided, however, that such parties shall use such telephone
54 numbers solely for the purposes indicated and shall not transfer such telephone numbers to any
55 third party:

56 (1) Any law enforcement agency, fire protection agency, public health agency,
57 public environmental health agency, city or county emergency services planning agency, or
58 private for-profit agency operating under contract with, and at the direction of, one or more of
59 these agencies, for the exclusive purpose of responding to a 911 call or communicating an
60 imminent threat to life or property. This information or these records shall not be open to
61 examination for any purpose not directly connected with the administration of the services
62 specified in this paragraph;

63 (2) A lawful process issued under state or federal law;

64 (3) A service supplier providing service between service areas for the provision to
65 the subscriber of telephone service between service areas, or third parties for the limited purpose
66 of providing collection and billing services for the service supplier;

67 (4) A service supplier to effectuate a subscriber's assigned telephone number
68 from the subscribers existing service supplier to a new service supplier;

69 (5) The [commission]; or

70 (6) A traditional telephone directory publisher, for the purposes of publishing a
71 directory in any format, so long as the information was published before the effective date of this
72 Act.

73 (F) Subsequent to the effective date of this Act, a traditional telephone directory publisher
74 must obtain the wireless subscriber's recorded oral, electronic, or written consent for the wireless
75 subscriber's name and wireless dialing number to be published in a traditional telephone
76 directory.

77 (G) No service supplier shall sell or otherwise provide a list of wireless numbers to any
78 telemarketer except that such numbers may be provided to a telemarketer affiliated with the
79 service supplier for the sole purpose of facilitating communication by or on behalf of the service
80 supplier as permitted under [insert citation].

81 (H) Every deliberate violation of this Act is grounds for a civil suit by the aggrieved
82 subscriber against the service supplier responsible for the violation.

83 (I) No service supplier shall be subject to criminal or civil liability for the release of
84 customer information as authorized by this Act.
