



## CSG SHARED STATE LEGISLATION

The CSG Committee on Shared State Legislation convened on Thursday, December 14 and Friday, December 15 to review Docket 39A of the 2019 SSL cycle. The docket contained 102 bills on a variety of issues.

For each bill, the committee had four options: include it in the SSL volume; include the bill in the volume as a note, which indicates that the committee believes the bill (and other similar bills addressing the topic) to be of interest to state leaders but a broader perspective is more warranted; defer consideration; or reject the bill.

The committee approved 26 bills to be included in the 2019 SSL volume and deferred action on 9 bills to the next meeting of the committee (September 2018). The committee also requested that notes be prepared for inclusion in the volume on three topics.

The committee members provided CSG staff instructions to include additional information on the constitutional issues surrounding the sharing of your marked ballot on social media.
