



The CSG Committee on Shared State Legislation convened on Friday, July 19th to review docket 40B of the 2020 SSL cycle. The docketed contained 102 bills on a variety of issues.

For each bill, the committee had four options: include it in the SSL volume; include the bill in the volume as a note, which indicates the committee believes the bill (and other similar bills addressing the topic) to be of interest to state leaders but a broader perspective is more warranted; defer consideration; or reject the bill.

the committee approved 10 bills to be included in the 2020 SSL volume and deferred action on 10 bills to a future SSL committee meeting. The committee also requested that notes be prepared for inclusion in the volume on 13 bills.
