# Application for Public Sector Apprenticeship Consortium

## Overview

The Council of State Governments (CSG), in partnership with the Urban Institute, is developing a Public Sector Apprenticeship Consortium of five states that will convene during CSG's 2021 National Conference. The Consortium will equip and empower state policymakers – particularly legislators and executive branch officials focused on workforce development, education, and economic policy issues – to develop and implement public sector apprenticeships in their states.

The advantages of public sector apprenticeships include:

- helping states recover from the economic impact of COVID-19 by fostering the development of sustainable workforce development practices;
- increasing the pipeline of qualified public sector employees;
- connecting individuals with high-quality jobs;
- spurring widespread workforce improvements by creating a model for other employers to follow; and
- empowering states to customize training and develop talent where it is needed.

## Objective

This initiative will provide a forum for participating states to learn about public sector apprenticeship best practices; become familiar with and discuss existing apprenticeship efforts in their states; and create an action plan for developing a public sector apprenticeship program.

The participating state teams – consisting of six individuals from each state – will discuss the costs, opportunities, and challenges of public sector apprenticeship in their states. (See the “Targeted Applicants” section below for information on how state teams will be created.) Consortium members will be provided evidence-based research, best practices in the field, multi-state comparable data, state-specific data, and access to a network of state and national experts. In addition, each state in the Consortium will receive ongoing technical assistance from The Council of State Governments, the Urban Institute, and subject-matter experts to assist in implementation of their public sector apprenticeship action plan.



The benefits of the Consortium include:

- opportunities for team building and interbranch collaboration through facilitated team discussions;
- access to technical assistance (TA) resources and in-state programming with subject-matter experts;
- greater understanding of the current regulatory environment in participants' states and help identifying barriers and challenges;
- the tools to develop a state action plan;
- the opportunity to learn from other states; and
- access to CSG/Urban Institute staff to facilitate conversations between state offices and other stakeholders.

## Funding

If selected, CSG will fund all essential costs associated with participation in the Consortium including travel and accommodations during convenings; and will provide meeting materials and technical assistance resources, in collaboration with the Urban Institute.

## Targeted Applicants

CSG is seeking applications from state governors offices and other executive branch offices such as the State Office of Apprenticeships and executive cabinets involved in labor, employment, workforce, and education issues interested in participating in the Consortium as a way to launch and/or expand their state's public sector apprenticeship efforts.

States are eligible regardless of the current status of public sector apprenticeship program development, including states that have not yet launched public sector apprenticeship efforts.

After selection, CSG will work closely with project leaders to identify the most relevant and critical stakeholders for each six-person state team, based on each state's unique strengths and challenges.<sup>1</sup> Developing public sector apprenticeships requires a collaborative approach across state government, including executive branch agencies and oversight boards and state legislatures.

External partners – such as industry, labor groups, intermediaries, and foundations – also can play a role. States will assemble diverse teams to reflect this reality.

Receipt of assistance is contingent on entering into and complying with the terms of an agreement with CSG.
