CSG looks forward to continuing to host our Medicaid 101 and Medicaid Leadership policy academies for the 2024 Medicaid Policy Academy. This year's policy academy will convene two classes, one virtually and one in-person, to educate and equip state policymakers to provide appropriate oversight over state Medicaid programs. The Medicaid 101 Policy Academy will allow those with an interest in Medicaid and state healthcare spending to convene virtually over multiple sessions to learn about the intersection of Medicaid and general healthcare issues. The Medicaid Leadership Academy program will bring together state administration and legislative officials for our traditional in-person three-day meeting for conversations around health care policy and a deep dive into the intricacies governing Medicaid programs.

Dependent on funds raised, the Medicaid Leadership Academy, CSG will convene 30 state policymakers, from both the legislative and executive branches, with experience in healthcare related issues looking for a deepening knowledge and discussion opportunity.
